Description of the program

This program involves a multidisciplinary approach to broadening and deepening, differentiation of education within the legal-political-economic and legal studies in the second cycle.

These are studies that are built from 3 modules that fall within the scope of contemporary international legal studies.

Modules that are provided are:

1. International law;

2. International Relations;

3. International Business Law;

At a time of world globalization, which is the main driver of global integration processes, it is crucial to recognize the importance of these international flows which are representatives of foreign and internal drivers of public policies and programs which dynamics are based on international law and international relations. These legal and political relations are implemented in international business that builds alliances and makes conflicts within national and international frameworks. Given the growing importance of these areas and trends to our country and its involvement in these global integrations, the program is designed to have the capacity to respond to these emerging needs of the country.

Career

After completion of this study program, students will be able on the basis of acquired knowledge and skills to work in the national institutions that implement the law, especially international law, international business law and international relations, and international institutions and organizations, which require this kind of professional education and skills from their staff. Students that will focus on international law have the possibility of continuing education in the national legal system and practicing of the national law.

Description of courses

Core courses

- **Contemporary Issues of International Law**

The purpose of this course is to present the international public law, which covers the principles and rules that govern relations between states and interactions between them, and between the States with other international actors. This course is designed to give students a global understanding of the rules governing international relations and, ultimately, to provide practical skills of legal reasoning and arguing, researching and writing on international affairs.

- **Theory of International Trade**

- International trade and economics; - International trade issues; - Mobility factors; - Various national trade policies; - Theory of International Trade (offer); - Theory of International Trade (demand). - Factors increasing and technological changes; - Trade and boosting the economy in developing countries; - Transport costs and the theory of location; - Commercial policy (customs tariff, exchange controls, state trading, price discrimination and cartel, economic integration); - International allocation, taxation and immigration; - Procedure of adjustment; - Turnover of capital (short-term and long-term capital); - International monetary arrangements;

- **International Relations and Globalization**

The course offers a historical review of the development of the initial international relations and ideas of international relations from the early 20th century and their analysis by the daily functioning of the international organizations, to the latest trends in international relations and globalization.

- **Research Methodology**

The course objective is to present research methodology through the analyses of how methods can be applied to research problem, how can one make a research project outline as a student, to critically address the relationship between theoretical framework, methodological approach, research question and analyzes. The essential purpose is to enable the students to independently develop research projects.

- **International Institutions**

This course covers theoretical issues in relation to international institutions of universal and regional level, their historical development, functions and role of responsibilities. Special attention is paid to the question of their role in solving collective problems and issues in global politics. The focus is placed on their role in the area of peace and security, economic development, human rights, democracy and the rule of law. The focus is on the main bodies within the institutions responsible for implementing these goals.

- **Theories of International Relations**

Besides the study of the dominant theories in the field of international relations, the course will analyze contemporary political and security problems in the world today, from the view of each of the theories of international relations. The subject will simultaneously analyze future, possible development of international relations through the discussion of the new world agenda and the main theoretical debates in international relations referring to the main theoretical protagonists from each of the theoretical currents in the area.

- **International Politics**

- Introduction to basic concepts in international politics; - International Relations (IR) and international politics (IP) - subject, terminology, specification. - Basic features periods of IP, history and diplomacy; - Key Features and problems of IP and diplomacy in the 19th and 20th centuries and decolonization; - East and West until the end of the Cold War. The main issues of IP and diplomacy in the post-bipolar world; - The political use of force;

- **Conflict Theory**

The subject analyzes why various armed conflicts occur, what are the most common types, what causes them and how specific models for the resolution of conflicts can be applied in specific cases. Theory of international relations, political sciences, law and sociological theories about the different types of conflicts will focus conflict four levels of analysis: global, national, social / ethnic and individual level.

- **International Governance**

The course examines learning theory of international governance and the practice of international territorial administration, primarily practice the UN of fifty years of the 20th century until today.

- **Master Thesis**

This module enables students to transfer their skills and knowledge to research and make more complex task of Master-Thesis. The module is designed to be fully practical and students to acquire the necessary knowledge and skills to approach writing the paper. The module has unique return result-to enable students to write the master thesis with minimal difficulties, and with maximum efficiency. The course aims to improve research techniques and style of writing paper, taking account to stop illegal means, such as plagiarism and infringement of copyright, which are prohibited by the Statute of SEEU.

Elective courses

- **Advanced English Language and Terminology 1**

Advanced English Language and Terminology 1 is designed for students who are already proficient users of English. It is aimed towards further improvement of all four language skills: reading, writing, listening and speaking. Topics and terminology to be discussed in the course are related to International Law.

- **Advanced English Language and Terminology 2**

Advanced English Language and Terminology 2 is designed for students who have already completed the course Advanced English Language and Terminology 1. It is aimed towards further improvement of English. The topics and terminologies to be discussed in the course are related to Agencies and other European Union Bodies.

- **Advanced English Language and Terminology 3**

Advanced English Language and Terminology 3 is designed for students who have already completed the course Advanced English Language and Terminology 2. Since this is the highest level of English students will search and discuss about the topics and materials taken from the Central Library of the European Union available on-line, which is open to specialists and researchers who wish to consult its works on European integration.

- **German Language 1**

This course introduces students to the basic structures of the German language. The participants will develop their communicative competence in reading, listening, speaking and writing. The course will enable the students to carry out simple daily conversations in shopping and restaurant and to talk about the past. The students will be introduced to the listening strategies and will be able to get meaning of the cultural information from reading simple texts. Also, phonetic peculiarities will be practiced in communicative contexts.

- **German Language 2**

This course is designed for students with previous knowledge. In this course, we will go beyond the simple communication, so that participants can discuss in more complex sentence structures their family and friends, about plans for the future and the past. The students will learn the declension of adjectives. They will practice reading and listening techniques and improve their pronunciation in special phonetics exercises. They will also write first coherent texts.

- **German Language 3**

Në këtë kurs do të sqarohen strukturat komplekse dhe kompetencat komunikuese në gjuhën gjermane. Pjesëmarrësit do të jenë në gjendje të shprehin dëshirat dhe qëllimet e tyre dhe të pasqyrojnë sekuencat kohore. Ata do të mund të komunikojnë në situata të përditshme (si kërkimi i banesës, udhëtimi, orientimi, marrëdhëniet etj.). Objekt mësimi, gjithashtu, do të jenë edhe tekstet më të vështira për dëgjim dhe lexim. Nga tekstet autentike (artikuj gazetash, tekste të shkurtra letrare etj.) studentët do të filtrojnë informacione nga fusha e kulturës dhe civilizimit. Gjithashtu në fushën e të shkruarit do të ushtrohet edhe përpilimi i thjeshtë i llojeve të ndryshme të teksteve. Во овој курс ќе бидат објаснети комплексни структури и комуникативни компетенции во германскиот јазик. Студентите ќе бидат во состојба да иразуваат желби и намери како и да опишуваат временски секвенции. Тие ќе можат да комуницираат во важни секојдневни ситуации (како барање на стан, патувања, ориентација, врски). Претенциозни текстови за слушање и читање ќе бидат предмет на наставата. Студентите ќе исфилтруваат културни и цивилизациjsки информации од автентични текстови (написи во весник, кратки литературни текстови). Од областа на пишувањето ќе биде вежбано составувањето на едноставни текстови. In this course, more complex structures and communicative competence in the German language are taught. The students will be able to express their wishes and intentions and to describe temporal sequences. They can communicate in everyday situations (such as housing, travel, orientation, relations) communicate. More sophisticated oral and written texts will be the main objective of the lesson. The students will get information about the culture from authentic materials (newspaper articles, short literary texts). The writing skill will be practiced through writing simple texts.

- **Rhetoric**

During its long history of 2,500 years, rhetoric was used to indicate many different things; but rhetoric nowadays is considered as the art of persuasion through language. Rhetoric marks the way that an individual is linked to a particular theme or idea in order to convince the others. Rhetoric is characterized by several distinguishing features.

- **Methodology of Teaching**

The aim of the course is to introduce the students to the basic teaching approaches and methods. They are expected to gain knowledge and skills in order to be able to apply the active educational tools. The course also offers development, learning and teaching as concepts and basic practices that allow teachers to teach about the development of thinking. Throughout this course, students will gain both theoretical background and entirety of strategies that will enable them to reflect and develop both their own and their students` critical thinking.

- **Multilingualism and multiculturalism**

The purpose of this subject will be multilingualism in multicultural societies as a social phenomenon. This phenomenon is massive in the world. During the lectures, more precise terms such as monoculturalism and multiculturalism will be considered. The term 'linguistic nationalism' has at least two forms of this nationalism, which collide with each other: for the leaders of the most powerful countries nationalism means expansion, and for minorities it takes the form of defiance and struggle for the affirmation of identity, despite such pressure. The emphasis during the program will be multiculturalism in education. In the schools curricula consists of contents from different cultures.

- **Selected Chapters of Advanced Topics in IT Applications for Preparing a Scientific Paper**

The aim of this subject is: - To display the technical elements, the structure of the text and design of a scientific research. - To enable students to acquire advanced knowledge and skills from selected advanced chapters of IT applications that will be needed in preparation of the scientific and research paper. - Practical application of these objectives in preparing student's individual research paper.

- **Selected Chapters of Advanced Applications for Statistical Data Processing**

The aim of this subject is: - To display the technical elements in the field of statistics: organizing, processing, comparing through analysis and publication of data. - To enable students to acquire advanced knowledge and skills from selected advanced chapters of the applications for statistical data processing. - Practical application of these objectives in statistical processing of data obtained from questionnaires, reports, scientific studies and other documents.

- **Professional Communication**

The course is focused on the development of those communication skills that are essential for effective functioning in the professional world. Students will study the process for analysis of different communication situations, and will accordingly comprehend them. Among the themes that will be covered are communication in organization, interpersonal and group communication, oral presentations, interviews for employment, professional business letters and interpersonal skills including group dynamics and teamwork.

- **Foreign Policy Analysis**

The theoretical part of the contents of this course will focus on the ways and the means of communication between states, media influence public opinion and foreign policy in creating of influence on various internal and external stakeholders in focusing on certain foreign policy issues. The practical part will be focused on analysis, open discussions and forecasts specific events in development.

- **European Union Law**

Historical review of the development of EU law from the initial ideas of European integration to basic agreements (the ECCS, EEC and Euratom, Maastricht, Amsterdam, Nice and Lisbon) and analysis by the daily functioning of the EU.

- **International Banking Law**

This course includes the following topics: - International trade and economics; - International trade issues; - Mobility factors, various national trade policies; - Theory of International Trade (offer), - Theory of International Trade (demand); - Increasing factors and technological changes; - Trade and boosting the economy in developing countries; - Transport costs and the theory of location; - Commercial policy (customs tariff, exchange controls, state trading, price discrimination and cartel, economic integration); - International allocation, taxation and immigration; - Procedure of adjustment; - Turnover of capital (short-term and long-term capital); - International monetary

arrangements;

- **Contemporary Social Problems**

The first objective of the course Contemporary social problems is to stimulate student meditative activity for a wide range of social problems of local and global nature. Lectures will be held with the exercises, which will enable us to penetrate deep into the core of the social factors that influence the occurrence of phenomena called social issues.

- **Comparative Analysis of Legal Systems**

The course offers a thorough knowledge of the different legal systems and traditions in the modern world, including the continental legal system (under which you learn Romanian, German, and Nordic legal family) and Anglo-American (common law) legal system and the right of the remote east and religious legal systems;
